NO changes or substitutions may be made after May 1<sup>st</sup>.
- Vendors have the option to be open on Friday evening, June 16<sup>th</sup>.
- There will be live music in the evening. Please note: You must be set up and ready to sell by 5 p.m. on Friday.
- Vendors must be set up and ready to sell by noon on Saturday until at least 7 p.m. (when parade starts). Activities will continue in the evening (such as fireworks, music, etc.) You may open early Saturday morning if you wish. The craft fair and kids' activities start at 9 a.m.
- Non-profits must secure a food handling license for this event. Please call us with questions.
